## Changes of Notice of Race

### **Change the following point of Notice of Race: (Point 2.2: Rules: )**

2.2 RRS 62.1 (a), (b) and (d) are deleted.

### **Change the following point of Notice of Race: (Point 2.5.3: Rules: )**

#### **CHANGE:**

2.5.3 [SP] denotes a rule for which a standard penalty will be applied by the race committee without a hearing. This changes RRS 60.5 (a), Appendix A5.1 and Appendix A5.2

**20.4** If a SCL club is unable to start a race because the OA cannot supply a boat for racing, the SCL club will get an average score (SCA) for that race according to RRS A9 (b). The average will be calculated based on the races that were sailed before the race mentioned. This changes 63.1, A5.1 and A5.2.

#### **Change the following point of Notice of Race: (Attachment F: Rules for Handling the Boats )**

The rule changes in UF1 have been approved by World Sailing under Regulation 28.1.5(b) on the condition that only the provided options are used. This appendix applies only when it is referred to in the Notice of Race and made available for all competitors.

#### **CHANGE:**

Umpired fleet races shall be sailed under The Racing Rules of Sailing as changed by this appendix. Races shall be umpired. The rule changes in UF1 have been approved by World Sailing under Regulation 20.3 (d) (i) on the condition that only the provided options are used. This appendix applies only when it is referred to in the Notice of Race and made available for all competitors.

#### **Change the following point of Notice of Race: (Attachment H: UF 3.4 (b) Penalties and Protests Initiated by an Umpire)**

(b) An umpire who decides, based on his own observation or a report received from any source, that a boat may have broken a rule, other than rule UF3.6 or rule 28 or a rule listed in rule UF3.3(a), may inform the protest committee for its action under rule 60.3. However, he will not inform the protest committee of an alleged breach of rule 14 unless there is damage or injury

#### **CHANGE:**

(b) An umpire who decides, based on his own observation or a report received from any source, that a boat may have broken a rule, other than rule UF3.6 or rule 28 or a rule listed in rule UF3.3(a), may inform the protest committee for its action under rule 60.1. However, he will not inform the protest committee of an alleged breach of rule 14 unless there is damage or injury

#### **Change the following point of Notice of Race: (Attachment H: UF 5.4: Protests; Requests for Redress or Reopening; Appeals; Other Proceedings)**

**UF 5.4** The time limit defined in rule UF5.3 also applies to protests under rule UF5.10. The protest committee shall extend the time limit if there is good reason to do so.

#### **CHANGE:**

**UF 5.4** The time limit defined in rule UF5.3 also applies to protests under rule UF5.9, UF 5.10 and UF 5.11 when such protests are permitted. The protest committee shall extend the time limit if there is good reason to do so.

#### **Change the following point of Notice of Race: (Attachment H: UF 5.6: Protests; Requests for Redress or Reopening; Appeals; Other Proceedings)**

**UF 5.6** The third sentence of rule 61.1(a) and all of rule 61.1(a)(2) are deleted.

#### **CHANGE:**

**UF 5.6** Rule 60.2 (a) (1) is changed to: 'If the protestor is a boat, she shall hail 'protest' and conspicuously display a red flag, at the first reasonable opportunity for each.

#### **Change the following point of Notice of Race: (Attachment H: UF 5.7: Protests; Requests for Redress or Reopening; Appeals; Other Proceedings)**

**UF 5.7** The first three sentences of rule 64.2 are changed to: ‘When the protest committee decides that a boat that is a party to a protest hearing has broken a rule, it may impose penalties other than disqualification, and may make any other scoring arrangement it decides is equitable. If a boat has broken a rule when not racing, the protest committee shall decide whether to apply any penalty to the race sailed nearest in time to that of the incident or make some other arrangement.’

#### **CHANGE:**

**UF 5.7** Rule 60.5 is changed to: ‘When the protest committee decides that a boat that is a *party* to a protest hearing has broken a *rule*, it may impose penalties other than disqualification, and may make any other scoring arrangement it decides is equitable. If a boat has broken a *rule* when not *racing*, the protest committee shall decide whether to apply any penalty to the race sailed nearest in time to that of the incident or make some other arrangement.’

#### **Change the following point of Notice of Race: (Attachment H: UF 5.10: Protests; Requests for Redress or Reopening; Appeals; Other Proceedings)**

**UF 5.10** The protest committee may protest a boat under rule 60.3. However, it will not protest a boat for breaking rule UF3.6 or rule 28, a rule listed in rule UF3.3(a), or rule 14 unless there is damage or injury.

#### **CHANGE:**

**UF 5.10** The protest committee may protest a boat under rule 60.1. However, it will not protest a boat for breaking rule UF3.6 or rule 28, a rule listed in rule UF3.3(a), or rule 14 unless there is damage or injury.

#### **Change the following point of Notice of Race: (Attachment H: UF 5.11: Protests; Requests for Redress or Reopening; Appeals; Other Proceedings)**

**UF 5.11** The technical committee will only protest a boat under rule 60.4 when decides that a boat or personal equipment does not comply with the class rule, rule 50, or the rules in the equipment regulations of the event, if such exist. In such a case, the technical committee shall protest.

#### **CHANGE:**

**UF 5.11** The technical committee will only protest a boat under rule 60.1 when decides that a boat or personal equipment does not comply with the class rule, rule 50, or the rules in the equipment regulations of the event, if such exist. In such a case, the technical committee shall protest.
